- **Michigan :**

OC Pepper spray can be no stronger than a 2% concentrate. CS is the only Tear Gas accepted and can be no larger than 35 grams per can. No combination spray allowed.

- **Wisconsin :**

Pepper only. No Tear gas, UV Dye or combination sprays. OC can be no stronger than a 10% solution. Can must be between 15-60 grams only. Must have safety feature.

- **California :**

Canisters cannot be more than 2.5 ounces.
